# ON PRODUCT IDENTITIES AND THE CHOW RINGS OF HOLOMORPHIC SYMPLECTIC VARIETIES

#### Abstract

For a moduli space M of stable sheaves over a $K 3$ surface $X$, we propose a series of conjectural identities in the Chow rings $C H_{\star}\left(\mathrm{M} \times X^{\ell}\right), \ell \geq 1$, generalizing the classic Beauville-Voisin identity for a $K 3$ surface. We emphasize consequences of the conjecture for the structure of the tautological subring $R_{\star}(\mathrm{M}) \subset C H_{\star}(\mathrm{M})$. The conjecture places all tautological classes in the lowest piece of a natural filtration emerging on $C H_{\star}(\mathrm{M})$, which we also discuss. We prove the proposed identities when M is the Hilbert scheme of points on a $K 3$ surface.


## 1. Introduction

Understanding the Chow ring of irreducible holomorphic symplectic varieties is a problem of considerable interest. In the case of a smooth projective $K 3$ surface $X$, an essential role in approaching the cycle structure is played by a distinguished zero-cycle $c_{X}$, first noted and studied in [BV]. The cycle $c_{X}$ has degree one and is the Chow class of any point lying on a rational curve in $X$. The intersection of any two divisors is a multiple of $c_{X}$, while the second Chern class of the tangent bundle satisfies

$$
c_{2}(T X)=24 c_{X}
$$

In higher dimensions, it is natural to consider moduli spaces of stable sheaves on $K 3$ surfaces. For a smooth projective $K 3$ surface $X$, we let $v \in H^{\star}(X, \mathbb{Z})$ be a primitive Mukai vector, and let M be the moduli space of stable sheaves over $X$ with Mukai vector $v$, relative to a $v$-generic polarization. We note nevertheless that all statements in this text apply more broadly to moduli spaces of Bridgeland-stable sheaf complexes with respect to a $v$-generic stability condition $\sigma$. The moduli space $M$ is a smooth projective irreducible holomorphic symplectic variety of dimension

$$
\operatorname{dim} \mathrm{M}=m=\langle v, v\rangle+2,
$$

admitting a quasi-universal sheaf

$$
\mathcal{F} \rightarrow \mathrm{M} \times X
$$

To keep the exposition simple we assume in fact that M is a fine moduli space, so $\mathcal{F}$ is a universal object. The restriction is not essential, as we later explain. We denote the two projections by $\pi: \mathrm{M} \times X \rightarrow \mathrm{M}$ and $\rho: \mathrm{M} \times X \rightarrow X$.

In parallel with the $K 3$ geometry, there is a distinguished zero-cycle

$$
c_{\mathrm{M}} \in C H_{0}(\mathrm{M})
$$

of degree one: this is the class of any stable sheaf $F$ such that

$$
\begin{equation*}
c_{2}(F)=k c_{X} \text { in } C H_{0}(X) \tag{1}
\end{equation*}
$$

where $k$ is the degree of the second Chern class specified by the Mukai vector $v$. Sheaves satisfying (11) exist in M (cf. OG2]), and have the same Chow class as shown in [MZ], following a conjecture of [SYZ]. In analogy with the surface situation, one expects ([V1], [SYZ]) that the special cycle corresponds to the largest rational equivalence orbit of points on M . The intersection-theoretic properties of $c_{\mathrm{M}}$ are not understood as well as those of its counterpart $c_{X}$ in the two-dimensional context.

We study the geometry of the universal sheaf and of the special cycles $c_{X}$ and $c_{\mathrm{M}}$ in two strands:
(1) We single out the tautological subring $R_{\star}(\mathrm{M}) \subset C H_{\star}(\mathrm{M})$, generated by the classes

$$
\pi_{\star}\left(M\left(c_{i}(\mathcal{F})\right) \cdot \rho^{\star} \beta\right)
$$

with $M$ any monomial in the Chern classes of $\mathcal{F}$, and $\beta$ any class in the Beauville-Voisin subring

$$
R_{\star}(X)=C H_{2}(X)+C H_{1}(X)+\mathbb{Z} c_{X} \subset C H_{\star}(X)
$$

(2) We emphasize the rank zero virtual sheaf

$$
\overline{\mathcal{F}}=\mathcal{F}-\rho^{\star} F \text {, with } F \in \mathrm{M} \text { such that }[F]=c_{\mathrm{M}} \in C H_{0}(\mathrm{M}) .
$$

Intuitively, the second Chern class of $\overline{\mathcal{F}}$ reflects to some extent the variation of rational equivalence classes across points in M , relative to the special class.

These two strands come together naturally within the framework of the following, which is the main conjecture of the paper.

Conjecture 1. Let $\alpha \in R_{\star}(\mathrm{M})$ be a tautological class of codimension d. Consider the product $\mathrm{M} \times X^{\ell}$, where $d+\ell>\operatorname{dim} \mathrm{M}$. Let $\overline{\mathcal{F}}_{i}$ denote the pullback to $\mathrm{M} \times X^{\ell}$ of the virtual universal sheaf on M and the $i$ th factor of $X$. Then for every $i_{1}, \ldots, i_{\ell} \geq 0$,

$$
\begin{equation*}
\alpha \cdot \operatorname{ch}_{i_{1}}\left(\overline{\mathcal{F}}_{1}\right) \cdots c h_{i_{\ell}}\left(\overline{\mathcal{F}}_{\ell}\right)=0 \in C H_{\star}\left(\mathrm{M} \times X^{\ell}\right) . \tag{2}
\end{equation*}
$$

The Künneth components along M of the Chern classes $c_{i}(\overline{\mathcal{F}})$ on $\mathrm{M} \times X$ have positive cohomological degrees for $i>0$. Since M has no odd cohomology, the products (2) are thus homologically trivial for dimension reasons due to the inequality $d+\ell>\operatorname{dim} \mathrm{M}$.

Conjecture 1 yields a rich collection of interesting Chow identities and we highlight some of them now. In case $\mathrm{M}=X$, viewed trivially as the Hilbert scheme of one point on itself, we have

$$
\overline{\mathcal{F}}=\overline{\mathcal{I}}, \text { where } \overline{\mathcal{I}}=\mathcal{I}_{\Delta}-\mathcal{I}_{X \times c} \text { on } X \times X
$$

with $c \in X$ a point of Chow class $c_{X}$. Therefore

$$
c h_{2}(\overline{\mathcal{F}})=c h_{2}(\overline{\mathcal{I}})=-\bar{\Delta}
$$

where we have set

$$
\bar{\Delta}=\Delta-X \times c_{X} \text { in } C H_{2}(X \times X)
$$

Thus when $\mathrm{M}=X$, for the tautological class $\alpha=1$, the identity

$$
\operatorname{ch}_{2}\left(\overline{\mathcal{F}}_{1}\right) \cdot \operatorname{ch}_{2}\left(\overline{\mathcal{F}}_{2}\right) \cdot \operatorname{ch}_{2}\left(\overline{\mathcal{F}}_{3}\right)=0 \text { in } C H_{2}\left(X \times X^{3}\right)
$$

predicted under (2) takes the form

$$
\begin{equation*}
\bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdot \bar{\Delta}_{03}=0 \text { in } C H_{2}\left(X \times X^{3}\right) \tag{3}
\end{equation*}
$$

while the $K$-theoretic identity

$$
\begin{equation*}
\overline{\mathcal{I}}_{01} \cdot \overline{\mathcal{I}}_{02} \cdot \overline{\mathcal{I}}_{03}=0 \text { in } K\left(X \times X^{3}\right) \tag{4}
\end{equation*}
$$

also holds. Here the index 0 is used to keep track of the first distinguished factor $X$ in the quadruple product $X^{4}$, and $\bar{\Delta}_{0 i}$ and $\overline{\mathcal{I}}_{0 i}$ indicate pullbacks from the 0 th and $i$ th factors.

Pushing forward to the product of the last three factors, equation (3) is easily seen to be equivalent to the fundamental Beauville-Voisin identity [BV]

$$
\begin{equation*}
\Delta-\Delta_{c}+\Delta_{c, c}=0 \text { in } C H_{2}(X \times X \times X) . \tag{5}
\end{equation*}
$$

Here $c$ again denotes a fixed point of Chow class $c_{X} ; \Delta$ is the small diagonal of points $(x, x, x) ; \Delta_{c}$ consists of triples of the form $(x, x, c),(c, x, x),(x, c, x) ; \Delta_{c, c}$ is the set of triples of the form $(c, c, x),(c, x, c),(x, c, c)$ for $x \in X$.

If we now take $\alpha=D$, a divisor class on $X$, the vanishing

$$
\alpha \cdot c h_{2}\left(\overline{\mathcal{F}}_{1}\right) \cdot c h_{2}\left(\overline{\mathcal{F}}_{2}\right)=0 \text { in } C H_{3}\left(X \times X^{2}\right)
$$

predicted by Conjecture 1 becomes

$$
\begin{equation*}
D^{(0)} \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02}=0 \text { in } C H_{3}\left(X \times X^{2}\right) \tag{6}
\end{equation*}
$$

(with the divisor $D$ pulled back from the 0th factor) which is known to hold. Indeed, any divisor class $D$ on $X$ is a linear combination of classes of rational curves on $X$, and the cycles $\bar{\Delta}_{01}, \bar{\Delta}_{02}$ restrict to zero for every point on a rational curve in the 0 th factor $X$. The spreading principle (cf. [V2, Theorem 3.1]) implies (6). We also note the trivial identity

$$
\begin{equation*}
c_{X}^{(0)} \cdot \bar{\Delta}_{01}=0 \text { in } C H_{0}(X \times X) . \tag{7}
\end{equation*}
$$

Returning now to the case of a general moduli space M , we see that for $\alpha=1$, the expected vanishing

$$
\begin{equation*}
\operatorname{ch}_{2}\left(\overline{\mathcal{F}}_{1}\right) \cdot \operatorname{ch}_{2}\left(\overline{\mathcal{F}}_{2}\right) \cdots \operatorname{ch}_{2}\left(\overline{\mathcal{F}}_{m+1}\right)=0 \text { in } C H_{m}\left(\mathrm{M} \times X^{m+1}\right) \tag{8}
\end{equation*}
$$

predicted by Conjecture 1 is the natural generalization of the Beauville-Voisin fundamental identity (5) in the triple product of a $K 3$ surface. The beautiful identity

$$
\begin{equation*}
\overline{\mathcal{F}}_{1} \cdot \overline{\mathcal{F}}_{2} \ldots \overline{\mathcal{F}}_{m+1}=0 \text { in } K\left(\mathrm{M} \times X^{m+1}\right) \tag{9}
\end{equation*}
$$

is also predicted by Conjecture 1 .
For tautological classes $\alpha \in R_{\star}(\mathrm{M})$ of positive codimension, the series of identities predicted by Conjecture 1 should be viewed as generalizing (6) and (7) from the $K 3$ context to a general moduli setup.

The identities of Conjecture 1 lead in turn to a large collection of conjectural Chow vanishings in the self-products $\mathrm{M} \times \mathrm{M} \times \cdots \times \mathrm{M}$. We set

$$
\bar{\Delta}=\Delta-\mathrm{M} \times c_{\mathrm{M}} \text { in } C H_{m}(\mathrm{M} \times \mathrm{M})
$$

and observe
Theorem 1. The system of identities (2) of Conjecture 1 is equivalent to the vanishing

$$
\begin{equation*}
\alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, \ell}=0 \text { in } C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell}\right) . \tag{10}
\end{equation*}
$$

for any tautological class $\alpha \in R_{\star}(\mathrm{M})$ of codimension $d$ and integer $\ell$ satisfying

$$
d+\ell>\operatorname{dim} \mathrm{M}
$$

Here the first factor of M is labeled by 0 , and $\alpha$ is pulled back from this factor.
Theorem 1 is immediately seen to have a few interesting consequences. At one end, if we take $\alpha \in R_{\star}(\mathrm{M})$ to be a tautological zero-cycle, and pick $\ell=1$, we obtain the vanishing

$$
\alpha \cdot \bar{\Delta}_{01}=0 \text { in } C H_{0}(\mathrm{M} \times \mathrm{M}) .
$$

Pushing forward to the second factor of M , this gives

$$
\alpha=n c_{\mathrm{M}}
$$

where $n$ is the degree of $\alpha$, and allows us to conclude
Corollary 1. Assuming Conjecture 1 holds, the tautological ring $R_{\star}(\mathrm{M})$ has rank one in dimension zero:

$$
R_{0}(\mathrm{M})=\mathbb{Q} \cdot c_{\mathrm{M}}
$$

At the other end, taking $\alpha=1$ yields the vanishing

$$
\begin{equation*}
\bar{\Delta}_{01} \cdots \bar{\Delta}_{0, m+1}=0 \text { in } C H_{m}\left(\mathrm{M} \times \mathrm{M}^{m+1}\right) \tag{11}
\end{equation*}
$$

It is easy to see that the pushforward of this product cycle, via the projection $\mathrm{M} \times \mathrm{M}^{m+1} \rightarrow \mathrm{M}^{m+1}$ forgetting the first factor, is the modified diagonal cycle studied in OG3. We thus obtain

Corollary 2. Assuming Conjecture 1 holds, the modified diagonal cycle

$$
\Gamma^{m+1}\left(\mathrm{M}, c_{\mathrm{M}}\right)=\Delta-\Delta_{c}+\Delta_{c, c}-\cdots+\Delta_{c, c, \ldots, c}
$$

vanishes in $C H_{m}\left(\mathrm{M}^{m+1}\right)$.
We also note
Corollary 3. Assuming Conjecture 1, for every codimension $0 \leq d \leq m$ there is a filtration

$$
\mathrm{S}_{0} \subset \mathrm{~S}_{1} \subset \cdots \subset \mathrm{~S}_{d-1} \subset \mathrm{~S}_{d}=C H^{d}(\mathrm{M})
$$

For a fixed codimension $d$ and $0 \leq i \leq d$ we set

$$
\mathrm{S}_{i}\left(C H^{d}(\mathrm{M})\right)=\left\{\alpha \text { with } \alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, m-d+i+1}=0 \subset C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{m-d+i+1}\right)\right\} .
$$

Here $\alpha$ is pulled back to the product from the first factor.
Clearly, in view of the conjectured vanishing (11), we would have

$$
\mathrm{S}_{d}=\left\{\alpha \text { with } \alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, m+1}=0 \subset C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{m+1}\right)\right\}=C H^{d}(\mathrm{M}) .
$$

Notice further that

$$
\mathrm{S}_{0}=\left\{\alpha \text { with } \alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, m-d+1}=0 \subset C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{m-d+1}\right)\right\} .
$$

Thus for every $d$, Conjecture 1 and Theorem 1 would place all codimension $d$ tautological classes in $\mathrm{S}_{0}\left(C H^{d}(\mathrm{M})\right)$. It is also known SYZ that M admits Lagrangian constant-cycle subvarieties for the special cycle $c_{\mathrm{M}}$. The spreading principle then places these subvarieties in $\mathrm{S}_{0}\left(C H^{n}(\mathrm{M})\right)$ for $n=m / 2$. We conjecture in Section 2 that they are in fact tautological.

As evidence for Conjecture 1, we show:
Theorem 2. Let $X$ be a smooth projective K3 surface. Conjecture 1 holds for $\mathrm{M}=X^{[n]}$, the Hilbert scheme of $n$ points on $X$.

A richer version of Theorem 1 is proven in Section 2 as Theorem $\mathbb{1}^{*}$. Section 2 also discusses the tautological subring of the Chow ring in a broader context, for the products $\mathrm{M} \times X^{\ell}, \ell \geq 0$. This leads to generalizations of Conjecture 1 and Theorem 22 to the setting of a product $\mathrm{M} \times X^{\ell}$ which are needed in the inductive argument of Section 3.

Theorem 2 is argued in Section 3 inductively on the number of points, using the geometry of the nested Hilbert scheme. The inductive technique, introduced in [EGL], is well understood in the context of universality arguments for series of intersection-theoretic invariants on the Hilbert scheme of a surface. In Theorem 2, we pursue nevertheless Chow identities in a large range of codimensions. Beyond the standard elements of the EGL] mechanism, we accordingly make strong use of the overhaul, on the level of Chow groups, of the Nakajima-Lehn commutator identities previously known to hold in cohomology. This overhaul was recently completed in [MN]. Finally, the base case of the induction beautifully comes down to the three fundamental $K 3$ identities (3), (6) and (77).

Together, Theorems 1 and 2 establish unconditionally a hierarchy of Chow identities involving the full tautological ring of the Hilbert scheme of a $K 3$ surface, for all codimensions. In this hierarchy, the "codimension-zero" identity is the vanishing of the modified diagonal cycle first established in [V3] (conditional on the forthcoming [V6]) which is thus placed in a vaster framework. The top codimension case is the assertion that the special cycle spans the tautological ring in dimension zero.

In Section 4 we discuss the filtration on all Chow groups introduced in Corollary 3. For zero-cycles, we compare it to the filtrations on $C H_{0}(\mathrm{M})$ studied in V1, [SYZ]. In higher dimensions, the placement of constant-cycle subvarieties within the filtration is investigated.

We note that in the context of the tautological ring of the product $\mathrm{M} \times X^{\ell}$ it is natural to formulate the stronger

Conjecture 2. The restriction of the cycle class map to the tautological subring,

$$
\tau: R_{\star}\left(\mathrm{M} \times X^{\ell}\right) \rightarrow H_{\star}\left(\mathrm{M} \times X^{\ell}\right)
$$

is injective.
This statement follows the line of conjectures on the injectivity of the cycle class map on suitable subrings of Chow initiated in [B2], V4]. It completely subsumes Conjecture 1, our main object in this paper. Indeed the identities (2) are among tautological classes and hold in homology. The advantage of Conjecture 1 is that it proposes a concrete set of relations in the Chow ring, and is thus easier to come to grips with than the elusive Conjecture 2.

Finally, the interesting problem of understanding corrections of the identities (2) in a relative setting over the moduli space of polarized $K 3$ surfaces is left for future exploration.

## 2. Tautological Rings and product cycles

2.1. Tautological rings. Let $X$ be a smooth projective $K 3$ surface, $v \in H^{\star}(X, \mathbb{Z})$ a primitive Mukai vector, and let M be the moduli space of stable sheaves with Mukai vector $v$ on $X$ relative to a $v$-generic polarization. To ease the exposition, we make the nonrestrictive assumption that M admits a universal family

$$
\mathcal{F} \rightarrow \mathrm{M} \times X
$$

If this is not the case, we use instead the universal Chern character $\operatorname{ch} \mathcal{F} \in C H_{\star}(\mathrm{M} \times$ $X$ ) discussed in Ma1], Ma2 to define the tautological ring, as well as to formulate the identities (2) of Conjecture 1. The construction in Section 3 of [Ma1] and Section 3.1 of [Ma2] follows the original explanation of [Mu2], Appendix A.5. Specifically, a universal sheaf can be glued together over $\mathbb{P} \times X$, where $\mathbb{P} \rightarrow \mathrm{M}$ is a suitable projective bundle over M . After appropriate twisting, the universal Chern character (but not the sheaf) is seen to descend as a rational class to the product $\mathrm{M} \times X$. When available, the universal sheaf is defined up to tensoring by line bundles from M. If a universal sheaf is not available, the universal Chern character is correspondingly (cf. Ma1], Section 3) defined up to multiplication by the Chern character of a line bundle over the moduli space. We now recall from the introduction:

Definition 1. The tautological ring

$$
R_{\star}(\mathrm{M}) \subset C H_{\star}(\mathrm{M})
$$

is the subring of Chow generated by the following classes

- $\pi_{\star}\left(M\left(c_{i}(\mathcal{F})\right)\right), \quad M$ any monomial in the Chern classes of $\mathcal{F}$;
- $\pi_{\star}\left(M\left(c_{i}(\mathcal{F})\right) \cdot \rho^{\star} D\right), D \in C H_{1}(X), M$ any monomial in the Chern classes of $\mathcal{F}$;
- $\pi_{\star}\left(M\left(c_{i}(\mathcal{F})\right) \cdot \rho^{\star} c_{X}\right), M$ any monomial in the Chern classes of $\mathcal{F}$.

Thus $R_{\star}(\mathrm{M})$ is generated by all classes of the form

$$
\pi_{\star}\left(M\left(c_{i}(\mathcal{F})\right) \cdot \rho^{\star} \beta\right)
$$

for an arbitrary monomial $M$ in the Chern classes of $\mathcal{F}$, and $\beta \in R_{\star}(X)$ any class in the Beauville-Voisin ring

$$
R_{\star}(X)=\mathbb{Z} c_{X}+C H_{1}(X)+C H_{2}(X) \subset C H_{\star}(X)
$$

As we repeatedly consider Chern characters, we will work throughout with $\mathbb{Q}$ coefficients.

It is useful to extend Definition 1 to the arbitrary products

$$
\mathrm{M} \times X^{k}, \text { for } k \geq 0
$$

For $1 \leq s \leq k$, let $\rho_{s}: \mathrm{M} \times X^{k} \rightarrow X$ be the map to the factor indexed by $s$, with the accompanying projection $\bar{\rho}_{s}: \mathrm{M} \times X^{k} \rightarrow \mathrm{M} \times X$. Denote by

$$
\mathcal{F}_{s}=\bar{\rho}_{s}^{\star} \mathcal{F}
$$

the universal sheaf on $\mathrm{M} \times X^{k}$ pulled back from $\mathrm{M} \times X$ via the $s$ th projection.
Definition 2. The tautological system of rings $R_{\star}\left(\mathrm{M} \times X^{k}\right) \subset C H_{\star}\left(\mathrm{M} \times X^{k}\right), k \geq 0$ is the smallest system of $\mathbb{Q}$-algebras satisfying the following three properties:
(i) $R_{\star}\left(\mathrm{M} \times X^{k}\right)$ contains the Chern classes $c_{i}\left(\mathcal{F}_{s}\right), 1 \leq s \leq k$, as well as the classes $\rho_{s}^{*} D$, for $D \in C H_{1}(X)$.
(ii) The system is closed under pushforward via the natural projections $\pi: \mathrm{M} \times$ $X^{n} \rightarrow \mathrm{M} \times X^{k}$ forgetting factors of $X$, where $n \geq k$.
(iii) The system is closed under pushforward via the natural inclusions $\iota: \mathrm{M} \times$ $X^{n} \rightarrow \mathrm{M} \times X^{k}$ for $n \leq k$ through diagonal embeddings of factors of $X$ or embeddings using the special cycle $c_{X}$.

Concretely, this means that for each $k \geq 1$, the subring $R_{\star}\left(\mathrm{M} \times X^{k}\right) \subset C H_{\star}(\mathrm{M} \times$ $X^{k}$ ) is generated by the following classes:

- the pullbacks $\pi^{\star} \alpha$ from M to the product $\mathrm{M} \times X^{k}$, where $\alpha \in C H_{\star}(\mathrm{M})$ is tautological in the sense of Definition 1.
- the Chern classes $c_{i}\left(\mathcal{F}_{s}\right), \quad 1 \leq s \leq k$;
- the pullback classes $\rho_{s}^{\star} D, \rho_{s}^{\star} c_{X}, 1 \leq s \leq k$;
- the diagonal classes $\rho_{r s}^{\star} \Delta, 1 \leq r, s \leq k$.
(It is straightforward to check that each of the classes above is in $R_{\star}\left(\mathrm{M} \times X^{k}\right)$, and that any polynomial in these classes satisfies the three properties in Definition 2. Thus they generate $R_{\star}\left(\mathrm{M} \times X^{k}\right)$.)

Remark 1. We note that the tautological ring $R_{\star}(\mathrm{M})$ is independent of the modular interpretation of the holomorphic symplectic manifold $M$. Suppose that

$$
\mathrm{M}=\mathrm{M}_{v} \simeq \mathrm{M}_{v^{\prime}},
$$

where $\mathrm{M}_{v^{\prime}}$ is a moduli space of stable sheaves with Mukai vector $v^{\prime}$ relative to a polarization $H^{\prime}$ over a $K 3$ surface $X^{\prime}$. There is then a derived (anti-)equivalence

$$
\Phi: D^{b}(X) \simeq D^{b}\left(X^{\prime}\right)
$$

with kernel $\mathcal{E} \in D^{b}\left(X \times X^{\prime}\right)$ inducing the isomorphism

$$
\bar{\Phi}: \mathrm{M}_{v} \rightarrow \mathrm{M}_{v^{\prime}}
$$

Let $\mathcal{F} \rightarrow \mathrm{M}_{v} \times X, \mathcal{F}^{\prime} \rightarrow \mathrm{M}_{v^{\prime}} \times X^{\prime}$ be the universal objects, and $\pi: \mathrm{M} \times X \rightarrow \mathrm{M}, \pi^{\prime}:$ $\mathrm{M} \times X^{\prime} \rightarrow \mathrm{M}$ the projections. Considering the extended equivalence induced by $\mathcal{E}$,

$$
\Phi_{\mathrm{M}}: D^{b}\left(\mathrm{M}_{v} \times X\right) \simeq D^{b}\left(\mathrm{M}_{v} \times X^{\prime}\right)
$$

we have

$$
\mathcal{F}_{0}={ }_{\operatorname{def}} \Phi_{\mathrm{M}}(\mathcal{F})=\left(\bar{\Phi} \times \operatorname{id}_{X^{\prime}}\right)^{\star}\left(\mathcal{F}^{\prime}\right)
$$

Let $\pi_{\star}^{\prime}\left(P\left(c_{i}\left(\mathcal{F}^{\prime}\right) \cdot \beta^{\prime}\right)\right.$ be a class on M tautological in the sense of $v^{\prime}$. Here $P$ is a polynomial in the Chern classes of the universal sheaf $\mathcal{F}^{\prime} \rightarrow \mathrm{M}_{v^{\prime}} \times X^{\prime}$ and $\beta^{\prime} \in R_{\star}\left(X^{\prime}\right)$ is in the Beauville-Voisin ring of $X^{\prime}$.

Under the identification $\bar{\Phi}$, we have

$$
\pi_{\star}^{\prime}\left(P\left(c_{i}\left(\mathcal{F}^{\prime}\right) \cdot \beta^{\prime}\right)=\pi_{\star}^{\prime}\left(P\left(c_{i}\left(\mathcal{F}_{0}\right) \cdot \beta^{\prime}\right)\right.\right.
$$

As

$$
\operatorname{ch} \mathcal{F}_{0}=\operatorname{ch} \Phi_{\mathrm{M}}(\mathcal{F})=\left(\pi \times \mathrm{id}_{X^{\prime}}\right)_{\star}(\operatorname{ch} \mathcal{F} \cdot \operatorname{ch} \mathcal{E} \cdot \operatorname{td} X)
$$

it is standard to write the pushforward $\pi_{\star}^{\prime}\left(P\left(c_{i}\left(\mathcal{F}_{0}\right) \cdot \beta^{\prime}\right)\right.$ from $\mathrm{M} \times X^{\prime}$ as a pushforward $\pi_{\star}\left(Q\left(c_{i}(\mathcal{F}) \cdot \beta\right)\right.$ from $\mathrm{M} \times X$, for some polynomial $Q$ in the Chern classes of the universal object $\mathcal{F}$ and a class $\beta \in C H_{\star}(X)$. Importantly, $\beta$ is in fact in the Beauville-Voisin subring $R_{\star}(X) \subset C H_{\star}(X)$ : as discussed in [H], the derived equivalence preserves Beauville-Voisin rings. Thus a tautological class in the sense of $\mathrm{M}_{v^{\prime}}$ is also tautological in the sense of $\mathrm{M}_{v}$.

### 2.2. Examples of tautological classes.

2.2.1. Divisors. It is well-known (cf. Mu1, Mu2, OG1, [Y]) that the determinant line bundle homomorphism

$$
\Theta_{v}: v^{\perp} \rightarrow N S(\mathrm{M})
$$

is an isomorphism for $\langle v, v\rangle>0$, and is in all cases surjective. Here

$$
v^{\perp} \subset H_{\text {alg }}^{\star}(X, \mathbb{Z})
$$

denotes the orthogonal complement of the Mukai vector $v$ in the algebraic Mukai lattice. Divisors on $M$ are thus tautological, making Definition 1 independent of the choice of universal family/universal Chern character.
2.2.2. Chern classes of the tangent bundle. We have

$$
\operatorname{ch}(T \mathrm{M})=2-\operatorname{ch} \mathcal{E} x t_{\pi}^{\bullet}(\mathcal{F}, \mathcal{F})=2-\pi_{\star}\left(\operatorname{ch} \mathcal{F}^{\vee} \cdot \operatorname{ch} \mathcal{F} \cdot \rho^{\star} \operatorname{td} X\right)
$$

therefore the Chern classes $c_{i}(T \mathrm{M})$ are tautological.
2.2.3. The special cycle $c_{\mathrm{M}}$. We show now that the distinguished zero-cycle $c_{\mathrm{M}}$ is tautological. Consider the product $\mathrm{M} \times \mathrm{M} \times X$, equipped with the universal sheaves $\mathcal{E}, \mathcal{F}$ which correspond to the two copies of M , and are pulled back to the product. Let $\pi: \mathrm{M} \times \mathrm{M} \times X \rightarrow \mathrm{M} \times \mathrm{M}$ be the projection. We form the natural relative Ext complex (shifted for convenience),

$$
\mathrm{W}(\mathcal{E}, \mathcal{F})=\mathcal{E} x t_{\pi}^{\bullet}(\mathcal{E}, \mathcal{F})[1] \text { on } \mathrm{M} \times \mathrm{M}
$$

We further fix $F_{0} \rightarrow X$ a sheaf parameterized by M , and denote by

$$
\mathrm{W}\left(\mathcal{E}, \rho^{\star} F_{0}\right)=\mathcal{E} x t_{\pi}^{\bullet}\left(\mathcal{E}, \rho^{\star} F_{0}\right)[1] \text { on } \mathrm{M}
$$

the pullback of $\mathrm{W}(\mathcal{E}, \mathcal{F})$ under the inclusion $\mathrm{M} \times\left[F_{0}\right] \hookrightarrow \mathrm{M} \times \mathrm{M}$.
As observed in [MZ], the complex W plays a role in understanding Chow classes of points on $M$, since the middle Chern class of $W$ is the class of the diagonal in the product $\mathrm{M} \times \mathrm{M}$. The formula

$$
\begin{equation*}
c_{m}(\mathrm{~W}(\mathcal{E}, \mathcal{F}))=[\Delta] \text { in } C H_{m}(\mathrm{M} \times \mathrm{M}) \tag{12}
\end{equation*}
$$

was established in Ma1, and is aligned with earlier work of Beauville B1 and Ellingsrud-Strømme [ES] on representing the diagonal in terms of the universal Chern classes, in the context of moduli spaces of Gieseker-stable sheaves. By pullback, the diagonal formula (12) gives

$$
\begin{equation*}
c_{m}\left(\mathrm{~W}\left(\mathcal{E}, \rho^{\star} F_{0}\right)\right)=\left[F_{0}\right] \text { in } C H_{0}(\mathrm{M}) \tag{13}
\end{equation*}
$$

and by Grothendieck-Riemann-Roch we have

$$
\operatorname{ch}\left(\mathrm{W}\left(\mathcal{E}, \rho^{\star} F_{0}\right)\right)=-\pi_{\star}\left[\operatorname{ch} \mathcal{E}^{\vee} \cdot \rho^{\star}\left(\operatorname{ch} F_{0} \cdot\left(1+2 c_{X}\right)\right)\right]
$$

In particular, if $F \in \mathrm{M}$ is any sheaf such that $c_{2}(F) \in C H_{0}(X)$ is a multiple of $c_{X}$, then

$$
\begin{equation*}
c_{\mathrm{M}}=[F]=c_{m}\left(\mathrm{~W}\left(\mathcal{E}, \rho^{\star} F\right)\right) \tag{14}
\end{equation*}
$$

is manifestly tautological.
Remark 2. As shown in [SYZ], there exist Lagrangian constant-cycle subvarieties for the special cycle $c_{\mathrm{M}}$. For any such subvariety $V \subset \mathrm{M}$ of dimension $n=m / 2$, the vanishing

$$
[V] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n+1}=0 \text { in } C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{n+1}\right)
$$

holds by the spreading principle ([V2], Theorem 3.1). We conjecture
Conjecture 3. The class of any Lagrangian constant-cycle subvariety for $c_{\mathrm{M}}$ is in the tautological ring $R_{\star}(\mathrm{M})$.
2.3. Vanishing of product cycles. We now show that the system of product identities of Conjecture 1 leads in turn to a large collection of conjectural Chow vanishings in the self-products $\mathrm{M} \times \mathrm{M} \times \cdots \times \mathrm{M}$. Among them is the vanishing of O'Grady's modified diagonal cycle. Aligned with our point of view, the modified diagonal cycle is also cast here in product form.

To start, let us single out the complex

$$
\begin{equation*}
\mathrm{W}(\mathcal{E}, \overline{\mathcal{F}})=\mathcal{E} x t_{\pi}^{\bullet}\left(\mathcal{E}, \mathcal{F}-\rho^{\star} F\right)[1] \text { on } \mathrm{M} \times \mathrm{M} \tag{15}
\end{equation*}
$$

where $F$ represents the special zero-cycle, $[F]=c_{\mathrm{M}}$, and $\mathcal{F}, \mathcal{E}$ are the universal objects on the first and second factors respectively.
We also set

$$
\bar{\Delta}=\Delta-\mathrm{M} \times c_{\mathrm{M}}=c_{m}(\mathrm{~W}(\mathcal{E}, \mathcal{F}))-c_{m}\left(\mathrm{~W}\left(\mathcal{E}, \rho^{\star} F\right)\right) \text { in } C H_{m}(\mathrm{M} \times \mathrm{M})
$$

Further, in the context of a product $\mathrm{M} \times \mathrm{M}^{\ell} \times X$, we let $\mathcal{E}_{1}, \ldots, \mathcal{E}_{\ell}, \mathcal{F}$ be the universal sheaves corresponding to the last $\ell$ factors of M , respectively the first distinguished factor. We label this factor by 0 , and show

Theorem $\mathbb{1}^{*}$. For any class $\alpha \in C H_{\star}(\mathrm{M})$ of codimension $d$ satisfying the inequality

$$
d+\ell>\operatorname{dim} \mathrm{M}
$$

the following three vanishing statements are equivalent.
(i) $\alpha \cdot \operatorname{ch}_{i_{1}}\left(\overline{\mathcal{F}}_{1}\right) \cdots \operatorname{ch}_{i_{\ell}}\left(\overline{\mathcal{F}}_{\ell}\right)=0 \in C H_{\star}\left(\mathrm{M} \times X^{\ell}\right)$, for all $i_{1}, \ldots, i_{\ell} \geq 0$. Here $\overline{\mathcal{F}}_{s}, 1 \leq s \leq \ell$, is the normalized universal sheaf pulled back from M and the sth factor in the product $X^{\ell}$.
(ii) $\alpha \cdot c_{i_{1}}\left(\mathrm{~W}\left(\mathcal{E}_{1}, \overline{\mathcal{F}}\right)\right) \cdot c_{i_{2}}\left(\mathrm{~W}\left(\mathcal{E}_{2}, \overline{\mathcal{F}}\right)\right) \cdots \cdot c_{i_{\ell}}\left(\mathrm{W}\left(\mathcal{E}_{\ell}, \overline{\mathcal{F}}\right)\right)=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell}\right)$, for all $i_{1}, \ldots, i_{\ell}>0$. Here the complex $\mathrm{W}\left(\mathcal{E}_{s}, \overline{\mathcal{F}}\right), 1 \leq s \leq \ell$, is pulled back from the distinguished factor M and the sth factor in the product $\mathrm{M}^{\ell}$.
(iii) $\alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, \ell}=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell}\right)$,

In all three cases, the class $\alpha$ is pulled back to the product from the first distinguished factor M .

Remark 3. Note that $(i)$ is the vanishing predicted by Conjecture 1 in case $\alpha$ is tautological. Theorem 1 is therefore the equivalence of $(i)$ and (iii) for $\alpha \in R_{\star}(\mathrm{M})$ and is completely subsumed by the statement above. The vanishing of the modified diagonal cycle, corresponding to $\alpha=1$, is thus implied by Conjecture 1 ,

Proof. We show first that (i) implies (ii). To start, we note that for the complex

$$
\mathrm{W}(\mathcal{E}, \overline{\mathcal{F}}) \text { on } \mathrm{M} \times \mathrm{M}
$$

each Chern class $c_{k}(\mathrm{~W}(\mathcal{E}, \overline{\mathcal{F}}))$ for $k>0$ is expressible in terms of pure-degree pieces of the Chern character, and is therefore a sum of products of factors of type

$$
\alpha_{i j}=\pi_{\star}\left[\operatorname{ch}_{i} \mathcal{E}^{\vee} \cdot \operatorname{ch} h_{j} \overline{\mathcal{F}} \cdot \operatorname{td} X\right] \quad \text { and } \beta_{i j}=\pi_{\star}\left[\mathrm{ch}_{i} \mathcal{E}^{\vee} \cdot \mathrm{ch} h_{j} \overline{\mathcal{F}}\right] .
$$

We consider now the larger product

$$
\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell}
$$

along with a class $\alpha \in C H_{\star}(\mathrm{M})$ pulled back from the distinguished first factor M , satisfying

$$
\operatorname{codim} \alpha+\ell>\operatorname{dim} \mathrm{M}
$$

We let $\mathcal{F}_{1}, \ldots \mathcal{F}_{\ell}$ be the universal sheaves pulled back from $\mathrm{M} \times X^{\ell}$, where M is the distinguished first factor. We also consider the universal sheaves $\mathcal{E}_{1}, \ldots \mathcal{E}_{\ell}$ on the new factors of M each paired with a factor of $X$.

By (i), the vanishing

$$
\alpha \cdot \operatorname{ch}_{j_{1}} \overline{\mathcal{F}}_{1} \cdots \operatorname{ch}_{j_{\ell}} \overline{\mathcal{F}}_{\ell}=0
$$

holds in $C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell}\right)$, pulled back from $\mathrm{M} \times X^{\ell}$. This trivially implies the vanishing of the larger product

$$
\alpha \cdot \operatorname{ch}_{i_{1}} \mathcal{E}_{1}^{\vee} \cdot \operatorname{ch}_{j_{1}} \overline{\mathcal{F}}_{1} \cdot\left(\operatorname{td} X_{1}\right)^{a_{1}} \cdots \operatorname{ch}_{i_{\ell}} \mathcal{E}_{\ell}^{\vee} \cdot \operatorname{ch}_{j_{\ell}} \overline{\mathcal{F}}_{\ell} \cdot\left(\operatorname{td} X_{\ell}\right)^{a_{\ell}}=0
$$

in $C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell}\right)$, for $i_{1}, j_{1}, \ldots i_{\ell}, j_{\ell} \geq 0$. Here the exponents $a_{1}, \ldots, a_{\ell}$ are either 0 or 1 . Pushing forward via the projection $\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell} \rightarrow \mathrm{M} \times \mathrm{M}^{\ell}$ gives

Lemma 1. Consider the product $\mathrm{M} \times \mathrm{M}^{\ell} \times X$ and a cycle $\alpha$ on the distinguished factor M , satisfying codim $\alpha+\ell>\operatorname{dim} \mathrm{M}$. Denote by $\mathcal{E}_{1}, \ldots \mathcal{E}_{\ell}, \mathcal{F}$ the universal sheaves associated with the last $\ell$ copies of M , respectively the first one, pulled back to the product $\mathrm{M} \times \mathrm{M}^{\ell} \times X$. Let $\pi: \mathrm{M} \times \mathrm{M}^{\ell} \times X \rightarrow \mathrm{M} \times \mathrm{M}^{\ell}$ be the projection. Then

$$
\begin{equation*}
\alpha \cdot \prod_{k=1}^{\ell} \pi_{\star}\left[c h_{i_{k}} \mathcal{E}_{k}^{\vee} \cdot c h_{j_{k}} \overline{\mathcal{F}} \cdot(t d X)^{a_{k}}\right]=0 \text { in } C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell}\right) \tag{16}
\end{equation*}
$$

for any $i_{k}, j_{k} \geq 0$, and $a_{k}$ taken either 0 or 1 .
As observed earlier, each factor $c_{i_{k}}\left(\mathrm{~W}\left(\mathcal{E}_{k}, \overline{\mathcal{F}}\right)\right)$ in the products $(i i)$ of Theorem $\mathbb{\square}^{*}$ is a sum of terms each containing a factor of type appearing in (16) of the lemma, so the vanishings (ii) follow.

Notice next that (ii) implies (iii). Indeed, we have in $K$-theory,

$$
\mathrm{W}(\mathcal{E}, \mathcal{F})=\mathrm{W}(\mathcal{E}, \overline{\mathcal{F}})+\mathrm{W}\left(\mathcal{E}, \rho^{\star} F\right) \text { in } K(\mathrm{M} \times \mathrm{M})
$$

therefore

$$
c_{m}(\mathrm{~W}(\mathcal{E}, \mathcal{F}))=\sum_{i=0}^{m} c_{i}(\mathrm{~W}(\mathcal{E}, \overline{\mathcal{F}})) \cdot c_{m-i}\left(\mathrm{~W}\left(\mathcal{E}, \rho^{\star} F\right)\right)
$$

and

$$
\bar{\Delta}=c_{m}(\mathbf{W}(\mathcal{E}, \mathcal{F}))-c_{m}\left(\mathbf{W}\left(\mathcal{E}, \rho^{\star} F\right)\right)=\sum_{i=1}^{m} c_{i}(\mathrm{~W}(\mathcal{E}, \overline{\mathcal{F}})) \cdot c_{m-i}\left(\mathrm{~W}\left(\mathcal{E}, \rho^{\star} F\right)\right)
$$

It is thus clear that any term in the expansion of the product $\bar{\Delta}_{01} \cdots \bar{\Delta}_{0, \ell}$ contains a product $c_{i_{1}}\left(\mathrm{~W}\left(\mathcal{E}_{1}, \overline{\mathcal{F}}\right)\right) \cdot c_{i_{2}}\left(\mathrm{~W}\left(\mathcal{E}_{2}, \overline{\mathcal{F}}\right)\right) \cdots c_{i_{\ell}}\left(\mathrm{W}\left(\mathcal{E}_{\ell}, \overline{\mathcal{F}}\right)\right)$ for some $i_{1}, \ldots, i_{\ell}>0$. Accordingly, the vanishing (ii) implies (iii).

Finally, it is easy to see that (iii) implies (i). We start with the vanishing

$$
\alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, \ell}=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell}\right),
$$

pulled back from $\mathrm{M} \times \mathrm{M}^{\ell}$ to the larger product $\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell}$. Trivally, we also have

$$
\alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, \ell} \cdot \operatorname{ch}_{i_{1}}\left(\mathcal{F}_{1}\right) \cdots \operatorname{ch}_{i_{\ell}}\left(\mathcal{F}_{\ell}\right)=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell}\right)
$$

for any $i_{1}, \ldots, i_{\ell} \geq 0$. Here each $\mathcal{F}_{s}$ is pulled back from a factor $\mathrm{M} \times X$ in the product $\mathrm{M}^{\ell} \times X^{\ell}$. Pushing forward under the projection $\mathrm{M} \times \mathrm{M}^{\ell} \times X^{\ell} \rightarrow \mathrm{M} \times X^{\ell}$ gives

$$
\alpha \cdot \operatorname{ch}_{i_{1}}\left(\overline{\mathcal{F}}_{1}\right) \cdots \operatorname{ch}_{i_{\ell}}\left(\overline{\mathcal{F}}_{\ell}\right)=0 \in C H_{\star}\left(\mathrm{M} \times X^{\ell}\right),
$$

for any $i_{1}, \ldots, i_{\ell} \geq 0$. This concludes the proof of the theorem.
2.4. Extension of Conjecture 1. We end this section by formulating the following natural extension of our main conjecture. In the context of the product $\mathrm{M} \times X^{k} \times X^{\ell}$, let us index by $\{1, \ldots, \ell\}$ the individual factors in the product $X^{\ell}$ and by $\{\hat{1}, \ldots, \hat{k}\}$ the factors in the product $X^{k}$. As usual, $\overline{\mathcal{F}}_{t}$ denotes the normalized universal sheaf from the $t$-th factor.

Conjecture $\mathbb{1}^{*}$. For any integers $k \geq 0$ and $\ell>0$ consider the product $\mathrm{M} \times X^{k} \times X^{\ell}$ and a tautological class $\alpha \in R^{d}\left(\mathrm{M} \times X^{k}\right)$ satisfying

$$
d+\ell>\operatorname{dim}\left(\mathrm{M} \times X^{k}\right)
$$

For any indices $i_{1}, \ldots, i_{\ell} \geq 0$, partition $\Omega \sqcup \Theta=\{1, \ldots, \ell\}$, assignment $s: \Theta \rightarrow$ $\{\hat{1}, \ldots, \hat{k}\}$ we have

$$
\alpha \cdot \prod_{t \in \Omega} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{F}}_{t}\right) \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t}, t}}\right)=0 \text { in } C H_{\star}\left(\mathrm{M} \times X^{k} \times X^{\ell}\right)
$$

Observe that Conjecture 1 is a special case of Conjecture $\mathbb{1}$, specifically the case $k=0$ and (necessarily) $\Theta=\varnothing$. In $K$-theory, Conjecture $\mathbb{1}^{*}$ predicts the natural generalization of (9), namely that for any $0 \leq a \leq \ell=\operatorname{dim} \mathrm{M}+2 k+1$ and assignment $s:\{a+1, \ldots, \ell\} \rightarrow\{\hat{1}, \ldots, \hat{k}\}$, we have:

$$
\overline{\mathcal{F}}_{1} \cdot \overline{\mathcal{F}}_{2} \cdots \overline{\mathcal{F}}_{a} \cdot \mathcal{O}_{\bar{\Delta}_{s_{a+1}, a+1}} \cdot \mathcal{O}_{\bar{\Delta}_{s_{a+2}, a+2}} \cdots \cdots \mathcal{O}_{\bar{\Delta}_{s_{\ell}, \ell}}=0
$$

In Section 3 we will prove the following, which implies Theorem 2 in the introduction.

Theorem $2^{*}$. Conjecture $\square^{k}$ holds when $\mathrm{M}=X^{[n]}$ is the Hilbert scheme of $n$ points on $X$.

## 3. The product identities for $\mathrm{M}=X^{[n]}$

The aim of this section is to prove Theorem [2*. We let $\mathcal{I}_{n}$ denote the ideal sheaf of the universal subscheme

$$
\mathcal{Z}_{n} \subset X^{[n]} \times X
$$

and set

$$
\overline{\mathcal{I}}_{n}:=\mathcal{I}_{n}-\rho^{*} I_{n}
$$

the rank zero virtual universal sheaf, where $I_{n}$ is the ideal sheaf on $X$ of any subscheme of length $n$ with $c_{2}\left(I_{n}\right)=n c_{X}$. We state the theorem explicitly. In the context of the product $X^{[n]} \times X^{k} \times X^{\ell}$, let us index by $\{1, \ldots, \ell\}$ the individual factors in the product $X^{\ell}$ and by $\{\hat{1}, \ldots, \hat{k}\}$ the factors in the product $X^{k}$. Further, $\overline{\mathcal{I}}_{n}^{(t)}$ denotes the normalized universal sheaf from the $t$-th factor. We then restate:

Theorem $\mathbf{2}^{*}$. For any integers $n \geq 1, \ell \geq 1, k \geq 0$, consider the product $X^{[n]} \times$ $X^{k} \times X^{\ell}$ and a tautological class $\alpha \in R^{d}\left(X^{[n]} \times X^{k}\right)$ satisfying

$$
d+\ell>2 n+2 k
$$

For any indices $i_{1}, \ldots, i_{\ell} \geq 0$, partition $\Omega \sqcup \Theta=\{1, \ldots, \ell\}$, assignment $s: \Theta \rightarrow$ $\{\hat{1}, \ldots, \hat{k}\}$ we have

$$
\alpha \cdot \prod_{t \in \Omega} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{I}}_{n}^{(t)}\right) \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t}, t}}\right)=0 \text { in } C H_{\star}\left(X^{[n]} \times X^{k} \times X^{\ell}\right) .
$$

3.1. Induction preliminaries. We argue inductively on the number of points using the geometry of the nested Hilbert scheme

$$
X^{[n, n+1]} \subset X^{[n]} \times X^{[n+1]}
$$

parametrizing pairs $\left(\xi, \xi^{\prime}\right) \in X^{[n]} \times X^{[n+1]}$ such that $\xi \subset \xi^{\prime}$. The inductive technique was first used in EGL to relate top intersections on $X^{[n+1]}$ and $X^{[n]} \times X$; we now recall its main features. Each point $\left(\xi, \xi^{\prime}\right) \in X^{[n, n+1]}$ corresponds to an exact sequence

$$
\begin{equation*}
0 \rightarrow I_{\xi^{\prime}} \rightarrow I_{\xi} \rightarrow \mathcal{O}_{x} \rightarrow 0 \tag{17}
\end{equation*}
$$

leading to projection maps

and globally to an isomorphism

$$
X^{[n, n+1]} \cong \mathbb{P}\left(\mathcal{I}_{n}\right)
$$

of smooth projective varieties.
An important role for the geometry of $X^{[n, n+1]}$ is played by the hyperplane line bundle

$$
\mathcal{L}=\mathcal{O}_{\mathbb{P}\left(\mathcal{I}_{n}\right)}(1)
$$

with first Chern class $c_{1}(\mathcal{L})=\lambda$. Letting

$$
\sigma=\phi \times p: X^{[n, n+1]} \rightarrow X^{[n]} \times X
$$

we have (cf. [EGL])

$$
\begin{equation*}
\sigma_{\star}\left(\lambda^{i}\right)=(-1)^{i} c_{i}\left(-\mathcal{I}_{n}\right) \tag{19}
\end{equation*}
$$

The following fundamental exact sequence on $X^{[n, n+1]} \times X$ relates the universal ideal sheaves and the exceptional line bundle $\mathcal{L}$ :

$$
\begin{equation*}
0 \rightarrow \psi_{X}^{\star} \mathcal{I}_{n+1} \rightarrow \phi_{X}^{\star} \mathcal{I}_{n} \rightarrow \pi^{\star} \mathcal{L} \otimes \sigma_{X}^{\star} \mathcal{O}_{\Delta} \rightarrow 0 \tag{20}
\end{equation*}
$$

Here (and elsewhere in the paper) we use the notation $f_{X}=f \times \mathrm{id}_{X}$; the map $\pi: \mathbb{P}\left(\mathcal{I}_{n}\right) \times X \rightarrow \mathbb{P}\left(\mathcal{I}_{n}\right)$ is the projection; $\Delta$ denotes the diagonal in $X \times X$, pulled back in (20) via $\sigma_{X}: X^{[n, n+1]} \times X \rightarrow X^{[n]} \times X \times X$.

Furthermore, for a vector bundle $F \rightarrow X$, let $F^{[n]}$ denote the associated tautological vector bundle on $X^{[n]}$,

$$
F^{[n]}=\pi_{\star}\left(\mathcal{O}_{\mathcal{Z}_{n}} \otimes \rho^{\star}(F)\right)
$$

As usual in this text, $\pi$ and $\rho$ are the projections from $X^{[n]} \times X$ to the first and second factors respectively. The $K$-theoretic equality

$$
\psi^{\star} F^{[n+1]}=\phi^{\star} F^{[n]}+\mathcal{L} \cdot p^{\star} F \text { in } K\left(X^{[n, n+1]}\right)
$$

follows from (20). In particular,

$$
\begin{equation*}
\mathcal{L}=\psi^{\star} \mathcal{O}^{[n+1]}-\phi^{\star} \mathcal{O}^{[n]} \text { in } K\left(X^{[n, n+1]}\right) \tag{21}
\end{equation*}
$$

The induction in EGL only tracks degrees of top codimension classes on the Hilbert scheme $X^{[n]}$. Since our argument involves Chow classes of arbitrary codimension, we note the following

Lemma 2. Let $\alpha$ be a class in $C H_{\star}\left(X^{[n+1]} \times X^{k}\right)$. Then

$$
\alpha=0 \Longleftrightarrow \sigma_{\star} \psi^{\star} \alpha=\sigma_{\star}\left(\lambda \cdot \psi^{\star} \alpha\right)=0 \text { in } C H_{\star}\left(X^{[n]} \times X \times X^{k}\right)
$$

In the statement of the lemma and also onwards, we abuse notation and denote

$$
\begin{aligned}
& \psi=\psi \times \operatorname{id}_{X^{[k]}}: X^{[n, n+1]} \times X^{k} \rightarrow X^{[n+1]} \times X^{k} \\
& \sigma=\sigma \times \operatorname{id}_{X^{[k]}}: X^{[n, n+1]} \times X^{k} \rightarrow X^{[n]} \times X \times X^{k}
\end{aligned}
$$

Proof. We use the description of the Chow groups of

$$
\text { Hilb }=\amalg_{n \geq 0} X^{[n]}
$$

in [dCM], as well as an aspect of Lehn's formulas in Chow recently established in [MN]. Recall first the definition of the Nakajima operators $\mathfrak{q}_{i}, \mathfrak{q}_{-i}, i>0$. For every $i>0$ consider the subscheme
$X^{[n, n+i]}=\left\{\left(I \supset I^{\prime}\right)\right.$ s.t. $I / I^{\prime}$ is supported at a single point $\left.x \in X\right\} \subset X^{[n]} \times X^{[n+i]}$,
with accompanying maps


This correspondence defines the operators:

$$
\begin{gathered}
\mathfrak{q}_{ \pm i}: C H_{\star}(\text { Hilb }) \rightarrow C H_{\star}(\text { Hilb } \times X), \\
\mathfrak{q}_{i}=(\psi \times p)_{\star} \circ \phi^{\star}, \\
\mathfrak{q}_{-i}=(\phi \times p)_{\star} \circ \psi^{\star},
\end{gathered}
$$

which satisfy the commutation relations in the Heisenberg algebra. By composition one can form any string operator

$$
\mathfrak{q}_{i_{1}} \cdots \mathfrak{q}_{i_{\ell}}: C H_{\star}(\text { Hilb }) \rightarrow C H_{\star}\left(\operatorname{Hilb} \times X^{\ell}\right)
$$

Any class $\Gamma \in C H_{\star}\left(X^{\ell}\right)$ then defines an endomorphism of $C H_{\star}($ Hilb $)$ via

$$
\mathfrak{q}_{i_{1}} \cdots \mathfrak{q}_{i_{\ell}}(\Gamma)=\pi_{1 *}\left(\mathfrak{q}_{i_{1}} \cdots \mathfrak{q}_{i_{\ell}} \cdot \pi_{2}^{*}(\Gamma)\right),
$$

where $\pi_{1}, \pi_{2}$ : Hilb $\times X^{\ell} \rightarrow$ Hilb, $X^{\ell}$ are the standard projections.
The main theorem of dCM establishes that all Chow classes of the Hilbert scheme arise from Chow classes of symmetric products $X^{\ell}$ through the Nakajima correspondences. To state this precisely, let the vacuum vector $v$ be the generator of $C H_{\star}\left(X^{[0]}\right) \simeq \mathbb{Q}$. Then

$$
\begin{equation*}
C H_{\star}(\text { Hilb })=\bigoplus_{\substack{n_{1} \geq \ldots \geq n_{\ell}>0 \\ \Gamma \in C H_{\star}\left(X^{\ell}\right)^{\text {sym }}}} \mathbb{Q} \cdot \mathfrak{q}_{n_{1}} \cdots \mathfrak{q}_{n_{\ell}}(\Gamma) \cdot v \tag{22}
\end{equation*}
$$

where $C H_{\star}\left(X^{\ell}\right)^{\text {sym }} \subset C H_{\star}\left(X^{\ell}\right)$ denotes the subring of classes invariant under transpositions (ij) for which $n_{i}=n_{j}$. The isomorphism (22) is induced by a correspondence whose transpose gives the inverse map. It follows that for each $n$,

$$
\bigoplus_{\substack{n_{1}+\ldots+n_{\ell}=n \\ n_{1} \geq \ldots \geq n_{\ell}>0}} \mathfrak{q}_{-\mathfrak{n}_{1}} \cdots \mathfrak{q}_{-n_{\ell}}: C H_{\star}\left(X^{[n]}\right) \longrightarrow \bigoplus_{\substack{n_{1}+\cdots+n_{\ell}=n \\ n_{1} \geq \cdots \geq n_{\ell}>0}} C H_{\star}\left(X^{\ell}\right)
$$

is injective.
The Chow groups of the products Hilb $\times X^{k}, k>0$, admit a parallel description, since the inverse of the isomorphism (22) is induced by the transpose correspondence. We thus have

$$
\begin{equation*}
C H_{\star}\left(\operatorname{Hilb} \times X^{k}\right)=\bigoplus_{\substack{n_{1} \geq \cdots \geq n^{\prime}>0 \\ \Gamma \in C H_{\star}\left(X^{X}+k\right)^{\text {sym }}}} \mathbb{Q} \cdot \mathfrak{q}_{n_{1}} \cdots \mathfrak{q}_{n_{l}}(\Gamma) \cdot v \tag{23}
\end{equation*}
$$

(Here $C H_{\star}\left(X^{\ell+k}\right)^{\text {sym }} \subset C H_{\star}\left(X^{\ell+k}\right)$ is the subring of classes invariant under transpositions on the first $\ell$ factors for which $n_{i}=n_{j}$.) Correspondingly, for every $n$ and $k$, the map

$$
\bigoplus_{\substack{n_{1}+\cdots+n_{\ell}=n \\ n_{1} \geq \ldots \geq n_{\ell}>0}} \mathfrak{q}_{-n_{1}} \cdots \mathfrak{q}_{-n_{\ell}}: C H_{\star}\left(X^{[n]} \times X^{k}\right) \longrightarrow \bigoplus_{\substack{n_{1}+\cdots+n_{\ell}=n \\ n_{1} \geq \cdots \geq n_{\ell}>0}} C H_{\star}\left(X^{\ell+k}\right)
$$

is injective.
For a class $\alpha \in C H_{\star}\left(X^{[n+1]} \times X^{k}\right)$ we thus have, relevant to the lemma:

$$
\mathfrak{q}_{-i}(\alpha)=0 \text { for all } i>0 \Longrightarrow \alpha=0
$$

Assume now that $\sigma_{\star} \psi^{\star} \alpha=\sigma_{\star}\left(\lambda \cdot \psi^{\star} \alpha\right)=0$. We note right away that

$$
\sigma_{\star} \psi^{\star}=\mathfrak{q}_{-1}: C H_{\star}\left(X^{[n+1]} \times X^{k}\right) \rightarrow C H_{\star}\left(X^{[n]} \times X \times X^{k}\right)
$$

Furthermore, recall from [L, Definition 3.8] that the boundary operator

$$
\delta: C H_{\star}\left(X^{[n]}\right) \rightarrow C H_{\star}\left(X^{[n]}\right)
$$

represents multiplication by the divisor class $c_{1}\left(\mathcal{O}^{[n]}\right)$ on $X^{[n]}$. Since via (21) we have

$$
\lambda=\psi^{\star} c_{1}\left(\mathcal{O}^{[n+1]}\right)-\phi^{\star} c_{1}\left(\mathcal{O}^{[n]}\right)
$$

the operation of pulling back via $\psi$, intersecting with the hyperplane $\lambda$, and pushing forward by $\sigma$, is the commutator $\mathfrak{q}_{-1}^{(1)}$ of $\mathfrak{q}_{-1}$ with the boundary $\delta$,

$$
\sigma_{\star}\left(\lambda \cdot \psi^{\star}\right)=\left[\delta, \mathfrak{q}_{-1}\right]=\mathfrak{q}_{-1}^{(1)}: C H_{\star}\left(X^{[n+1]} \times X^{k}\right) \rightarrow C H_{\star}\left(X^{[n]} \times X \times X^{k}\right)
$$

It is known that the operators $\mathfrak{q}_{-1}$ and $\mathfrak{q}_{-1}^{(1)}$ generate all Nakajima lowering operators on the level of Chow, as explained in [MN]. To be precise (cf. [MN] equation (1.12)
in Theorem 1.7), we have

$$
\left[\mathfrak{q}_{-1}^{(1)}, \mathfrak{q}_{-i}\right]=i \Delta_{\star}\left(\mathfrak{q}_{-i-1}\right)
$$

The left and right side are homomorphisms $C H_{\star}\left(\right.$ Hilb $\left.\times X^{k}\right) \rightarrow C H_{\star}\left(\right.$ Hilb $\left.\times X^{2} \times X^{k}\right)$ where the last $k$ factors of $X$ are inert for the Chow action. Thus

$$
\mathfrak{q}_{-1}(\alpha)=\mathfrak{q}_{-1}^{(1)}(\alpha)=0 \Longrightarrow \mathfrak{q}_{-i}(\alpha)=0 \text { for all } i>0 \Longrightarrow \alpha=0
$$

This ends the proof of the lemma.
3.2. Proof of Theorem $\mathbf{2}^{*}$. We now complete the inductive argument giving the theorem.
3.2.1. The base case $n=1$. The proof of Theorem $2^{*}$ follows in this case from the three identities stated in the introduction,

$$
\begin{gather*}
\bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdot \bar{\Delta}_{03}=0 \text { in } C H_{2}\left(X \times X^{3}\right)  \tag{24}\\
D^{(0)} \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02}=0 \text { in } C H_{3}\left(X \times X^{2}\right),  \tag{25}\\
c_{X}^{(0)} \cdot \bar{\Delta}_{01}=0 \text { in } C H_{0}(X \times X), \tag{26}
\end{gather*}
$$

of which the first one is the Beauville-Voisin identity.
We have $X^{[1]}=X$ and the universal ideal sheaf is

$$
\mathcal{I}_{1}=\mathcal{I}_{\Delta} \text { on } X \times X
$$

A tautological class $\alpha \in R^{d}\left(X \times X^{k}\right)$ is a polynomial in pullbacks of diagonals, divisors, and special cycles $c_{X}$ from various factors of the product $X^{k+1}$. Thus $\alpha$ is necessarily a linear combination of subvarieties of $X^{k+1}$ of type

$$
\begin{equation*}
c_{X}^{(1)} \times \cdots \times c_{X}^{(a)} \times D_{1}^{(a+1)} \times \cdots \times D_{b}^{(a+b)} \times X^{(a+b+1)} \times \cdots \times X^{(a+b+c)} \subset X^{k+1} \tag{27}
\end{equation*}
$$

where the embedding in $X^{k+1}$ is by diagonals (and up to ordering of the factors). Here $a+b+c \leq k+1$ and

$$
\operatorname{dim} \alpha=b+2 c
$$

We now assume $\alpha$ is of the form (27). Indexing the first copy of $X$ by 0 , we have

$$
\overline{\mathcal{I}}_{1}^{(t)}=-\mathcal{O}_{\bar{\Delta}_{0, t}}
$$

in $K$-theory. We seek to establish the vanishing

$$
\alpha \cdot \prod_{t \in \Omega} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{0, t}}\right) \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t, t}}}\right)=0 \text { in } C H_{\star}\left(X \times X^{k} \times X^{\ell}\right)
$$

whenever $\ell>\operatorname{dim} \alpha$. Here $t$ runs through $\{1, \ldots, \ell\}$ and $\Omega \sqcup \Theta=\{1, \ldots, \ell\}$. The Chern character degrees $i_{t}$ are arbitrary.

Noting now that in $X \times X$ we have

$$
\operatorname{ch}\left(\mathcal{O}_{\bar{\Delta}}\right)=\bar{\Delta}-2 c_{X} \times c_{X}
$$

and the cycle $c_{X} \times c_{X}$ is a rational multiple of $\bar{\Delta}^{2}$, it is enough to show the vanishing

$$
\begin{equation*}
\alpha \cdot \prod_{t \in \Omega} \bar{\Delta}_{0, t} \cdot \prod_{t \in \Theta} \bar{\Delta}_{s_{t}, t}=0 \text { in } C H_{\star}\left(X \times X^{k} \times X^{\ell}\right) \tag{28}
\end{equation*}
$$

whenever $\ell>\operatorname{dim} \alpha=b+2 c$. Since $\alpha$ is of the form (27), this inequality guarantees that a factor of $c_{X}$ receives a matching normalized diagonal, or a factor of $D$ receives two matching normalized diagonals, or a factor of $X$ receives three matching normalized diagonals. (Here "matching" means that the normalized diagonal shares an index with the class in question.) The fundamental identities (24), (25), (26) therefore ensure that the product (28) vanishes.
3.2.2. The induction step. Let $\alpha \in R^{d}\left(X^{[n+1]} \times X^{k}\right)$. We want to show that for every $\ell$ satisfying

$$
\ell>\operatorname{dim} \alpha,
$$

and any indices $i_{1}, \ldots, i_{\ell} \geq 0$, the class

$$
\begin{equation*}
\gamma:=\alpha \cdot \prod_{t \in \Omega} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{I}}_{n+1}^{(t)}\right) \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t}, t}}\right)=0 \text { in } C H_{\star}\left(X^{[n+1]} \times X^{k} \times X^{\ell}\right) . \tag{29}
\end{equation*}
$$

According to Lemma 2 it suffices to show

$$
\sigma_{\star} \psi^{\star} \gamma=\sigma_{\star}\left(\lambda \cdot \psi^{\star} \gamma\right)=0 \text { in } C H_{\star}\left(X^{[n]} \times X^{k+1} \times X^{\ell}\right)
$$

To start, note that as a tautological class, $\alpha$ is a polynomial in classes

$$
\beta_{j}, \quad \Delta_{s, s^{\prime}}, \quad D^{(s)}, \quad c_{X}^{(s)}, \quad \text { and } \quad \operatorname{ch}_{i}\left(\mathcal{I}_{n+1}^{(s)}\right)
$$

with $\beta_{j} \in R^{\star}\left(X^{[n+1]}\right)$ and $s \in\{\hat{1}, \ldots, \hat{k}\}$. Recalling the exact sequence (20),

$$
0 \rightarrow \psi_{X}^{\star} \mathcal{I}_{n+1} \rightarrow \phi_{X}^{\star} \mathcal{I}_{n} \rightarrow \pi^{\star} \mathcal{L} \otimes \sigma_{X}^{\star} \mathcal{O}_{\Delta} \rightarrow 0 \text { on } X^{[n, n+1]} \times X
$$

it follows that the pullback $\psi^{\star} \alpha$ is of the form

$$
\begin{equation*}
\psi^{\star} \alpha=\sum_{j=0}^{d} \alpha_{d-j} \cdot \lambda^{j} \in C H_{\star}\left(X^{[n, n+1]} \times X^{k}\right) \tag{30}
\end{equation*}
$$

where

$$
\alpha_{d-j} \in R^{d-j}\left(X^{[n]} \times X^{k+1}\right)
$$

are pulled back under $\sigma \times \mathrm{id}_{X^{k}}: X^{[n, n+1]} \times X^{k} \rightarrow X^{[n]} \times X^{k+1}$. (Here we suppressed the pullback from the notation.)

Furthermore, the fundamental exact sequence (20) gives immediately the $K$ theoretic equality

$$
\overline{\mathcal{I}}_{n+1}^{(t)}=\overline{\mathcal{I}}_{n}^{(t)}-\mathcal{L} \cdot \mathcal{O}_{\bar{\Delta}_{0, t}}-(\mathcal{L}-1) \cdot \mathcal{O}_{c_{X}^{(t)}} \quad \text { in } \quad K\left(X^{[n, n+1]} \times X^{\ell}\right)
$$

Here 0 denotes the factor of $X$ which $X^{[n, n+1]}$ maps to under $p: X^{[n, n+1]} \rightarrow X$; we suppressed the pullbacks from the notation; as usual $t$ indexes the factors in $X^{\ell}$.

Thus the class $\psi^{\star} \gamma \in C H_{\star}\left(X^{[n, n+1]} \times X^{k} \times X^{\ell}\right)$ is a linear combination of terms of the form

$$
\begin{equation*}
\psi^{\star} \alpha \cdot \prod_{t \in \Omega_{1}} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{I}}_{n}^{(t)}\right) \cdot \prod_{t \in \Omega_{2}} \operatorname{ch}_{i_{t}}\left(\mathcal{L} \otimes \mathcal{O}_{\bar{\Delta}_{0, t}}\right) \cdot \prod_{t \in \Omega_{3}} \operatorname{ch}_{i_{t}}\left((\mathcal{L}-1) \otimes \mathcal{O}_{c_{X}^{(t)}}\right) \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t, t}}}\right) \tag{31}
\end{equation*}
$$

Here $\Omega_{1} \sqcup \Omega_{2} \sqcup \Omega_{3} \sqcup \Theta=\{1, \ldots, \ell\}$, the indexing set for factors in the product $X^{\ell}$, and $\psi^{\star} \alpha$ is the codimension $d$ class given by (30). The expression (31) is a polynomial in $\lambda$ with coefficients pulled back from $R_{\star}\left(X^{[n]} \times X^{k+1} \times X^{\ell}\right)$. Noting now that

$$
\operatorname{ch}\left((\mathcal{L}-1) \otimes \mathcal{O}_{c_{X}^{(t)}}\right)=\lambda \cdot p(\lambda) \cdot c_{X}^{(t)} \text { for } p \in \mathbb{Q}[\lambda]
$$

we conclude from (31) that the classes $\psi^{\star} \gamma, \lambda \cdot \psi^{\star} \gamma \in C H_{\star}\left(X^{[n, n+1]} \times X^{k} \times X^{\ell}\right)$ are linear combinations of terms of type

$$
\widetilde{\alpha} \cdot \prod_{t \in \Omega_{1}} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{I}}_{n}^{(t)}\right) \cdot \prod_{t \in \Omega_{2}} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{0, t}}\right) \cdot \prod_{t \in \Omega_{3}} c_{X}^{(t)} \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t}, t}}\right),
$$

where the quadruple product is now pulled back from $R_{\star}\left(X^{[n]} \times X^{k+1} \times X^{\ell}\right)$. The class $\widetilde{\alpha}$ is a polynomial in $\lambda$ with coefficients in $R_{\star}\left(X^{[n]} \times X^{k+1}\right)$, and

$$
\operatorname{codim} \widetilde{\alpha} \geq d+\omega, \text { where } \omega=\left|\Omega_{3}\right|
$$

Correspondingly, since powers of $\lambda$ push forward to tautological classes (cf. (19)), the pushforwards $\sigma_{\star} \psi^{\star} \gamma$ and $\sigma_{\star}\left(\lambda \cdot \psi^{\star} \gamma\right)$ are linear combinations of terms of the form

$$
\beta \cdot \prod_{t \in \Omega_{1}} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{I}}_{n}^{(t)}\right) \cdot \prod_{t \in \Omega_{2}} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{0, t}}\right) \cdot \prod_{t \in \Omega_{3}} c_{X}^{(t)} \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t}, t}}\right),
$$

for $\beta \in R_{\star}\left(X^{[n]} \times X^{k+1}\right)$ satisfying

$$
d^{\prime}:=\operatorname{codim} \beta \geq d+\omega
$$

Setting $\ell^{\prime}=\ell-\omega$ and omitting the $X$ factors which carry a class $c_{X}$, we note that the product

$$
\beta \cdot \prod_{t \in \Omega_{1}} \operatorname{ch}_{i_{t}}\left(\overline{\mathcal{I}}_{n}^{(t)}\right) \cdot \prod_{t \in \Omega_{2}} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{0, t}}\right) \cdot \prod_{t \in \Theta} \operatorname{ch}_{i_{t}}\left(\mathcal{O}_{\bar{\Delta}_{s_{t}, t}}\right)=0 \in R_{\star}\left(X^{[n]} \times X^{k+1} \times X^{\ell^{\prime}}\right)
$$

by the induction hypothesis, since $d^{\prime}+\ell^{\prime} \geq d+\ell>2 n+2 k+2$.

## 4. The Chow filtration

In this section we examine the filtration on $C H_{\star}(\mathrm{M})$ proposed in the introduction, in Corollary 3. The filtration is natural to the product point of view of this paper.

Within its framework, all dimensions are treated uniformly. For a fixed codimension $d$ and $0 \leq i \leq d$ we set

$$
\begin{equation*}
\mathrm{S}_{i}\left(C H^{d}(\mathrm{M})\right)=\left\{\alpha \text { with } \alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, m-d+i+1}=0 \subset C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{m-d+i+1}\right)\right\} \tag{32}
\end{equation*}
$$

Here $\alpha$ is pulled back to the product from the first factor. We have

$$
\mathrm{S}_{0} \subset \mathrm{~S}_{1} \subset \mathrm{~S}_{2} \subset \ldots
$$

The filtration depends (in order for it to terminate as wished) on the conjectural vanishing (11),

$$
\bar{\Delta}_{01} \cdots \bar{\Delta}_{0, m+1}=0 \text { in } C H_{m}\left(\mathrm{M} \times \mathrm{M}^{m+1}\right)
$$

which is the codimenson zero case of Conjecture 1. This identity would ensure that $\mathrm{S}_{d}\left(C H^{d}(\mathrm{M})\right)=C H^{d}(\mathrm{M})$. The filtration remains thus conjectural in arbitrary dimension until (11) is established, although as we will see immediately, for certain cases (e.g., dimension zero) one can argue the expected termination directly.

Theorem $\mathbb{1}^{*}$ is a useful tool for analyzing $\mathrm{S}_{\bullet}$ : for a class $\alpha \in C H_{\star}(\mathrm{M})$, it asserts

$$
\begin{gathered}
\alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, \ell}=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{\ell}\right) \Longleftrightarrow \\
\alpha \cdot \operatorname{ch}_{i_{1}}\left(\overline{\mathcal{F}}_{1}\right) \cdots \operatorname{ch}_{i_{\ell}}\left(\overline{\mathcal{F}}_{\ell}\right)=0 \in C H_{\star}\left(\mathrm{M} \times X^{\ell}\right), \text { for all } i_{1}, \ldots, i_{\ell} \geq 0
\end{gathered}
$$

4.1. The filtration for zero-cycles. We examine the filtration first for zero-cycles, when $d=m$. In this case we simply have

$$
\begin{equation*}
\mathrm{S}_{i}\left(C H_{0}(\mathrm{M})\right)=\left\{\alpha \text { with } \alpha \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, i+1}=0 \subset C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{i+1}\right)\right\} \tag{33}
\end{equation*}
$$

For a cycle $\eta \in C H_{\star}(\mathrm{M})$, we use the notation

$$
\eta^{\boxtimes \ell}=p_{1}^{\star} \eta \cdot p_{2}^{\star} \eta \cdots p_{\ell}^{\star} \eta \in C H_{*}\left(\mathbf{M}^{\ell}\right)
$$

where $p_{j}: \mathrm{M}^{\ell} \rightarrow \mathrm{M}, 1 \leq j \leq \ell$, is the projection on the $j$ th factor. By definition then, for a point class $[F]$ with $F \in \mathrm{M}$, we have

$$
[F] \in \mathrm{S}_{i} \Longleftrightarrow\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(\mathrm{M}^{i+1}\right) .
$$

For a zero-cycle $\alpha \in C H_{0}(\mathrm{M})$, the vanishings

$$
\alpha \cdot \operatorname{ch}_{i_{1}}\left(\overline{\mathcal{F}}_{1}\right) \cdots \operatorname{ch}_{i_{\ell}}\left(\overline{\mathcal{F}}_{\ell}\right)=0 \in C H_{\star}\left(\mathrm{M} \times X^{\ell}\right) \text { for } i_{1}, \ldots, i_{\ell} \geq 0
$$

hold trivially unless

$$
i_{1}=i_{2}=\cdots=i_{\ell}=2
$$

In the latter case, we can equivalently replace the second Chern character by the second Chern class. We thus have, in consequence of Theorem $\square^{*}$,

$$
\begin{align*}
{[F] \in \mathrm{S}_{i}\left(C H_{0}(\mathrm{M})\right) } & \Longleftrightarrow\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(\mathrm{M}^{i+1}\right) \\
& \Longleftrightarrow\left(c_{2}(F)-k c_{X}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(X^{i+1}\right) . \tag{34}
\end{align*}
$$

Here we set

$$
k=\int_{X} c_{2}(F) \in \mathbb{Z}, \text { for } F \in \mathrm{M}
$$

the degree of the second Chern class for sheaves with Mukai vector $v=v(F)$.

### 4.2. A comparison with the Voisin and Shen-Yin-Zhao filtrations on $C H_{0}(\mathrm{M})$.

 The filtration S. is closely related to the following two filtrations previously studied in the context of zero-cycles on M . For the rest of the paper we set$$
m=\operatorname{dim} \mathrm{M}=2 n
$$

Following [V1], we let

$$
\begin{gather*}
\mathrm{S}_{i}^{V}=\text { subgroup of } C H_{0}(\mathrm{M}) \text { generated by point classes }[F], F \in \mathrm{M}  \tag{35}\\
\text { with } \operatorname{dim} O_{F} \geq n-i
\end{gather*}
$$

Here $O_{F}$ denotes the rational equivalence orbit of a point $F \in \mathrm{M}$,

$$
O_{F}=\left\{E \in \mathrm{M} \mid[E]=[F] \text { in } C H_{0}(\mathrm{M})\right\},
$$

a countable union of subvarieties of M . The dimension of the orbit is the largest occurring dimension among these subvarieties.

A second filtration was introduced in a general moduli context in [SYZ, in relation to O'Grady's OG2 classic filtration on $C H_{0}(X)$. We let:

$$
\begin{equation*}
\mathrm{S}_{i}^{S Y Z}=\text { subgroup of } C H_{0}(\mathrm{M}) \text { generated by point classes }[F], F \in \mathrm{M} \text {, } \tag{36}
\end{equation*}
$$

$$
\text { with } c_{2}(F)=Z_{i}+(k-i) c_{X} \in C H_{0}(X) \text {, where } Z_{i} \text { is effective of degree } i \text {. }
$$

It is known [V1] that these two filtrations agree for the Hilbert scheme of points,

$$
\mathrm{S}_{\bullet}^{V}\left(C H_{0}\left(X^{[n]}\right)\right)=\mathrm{S}_{\bullet}^{S Y Z}\left(C H_{0}\left(X^{[n]}\right)\right)
$$

In a general setting, for a moduli space M with arbitrary primitive Mukai vector and generic polarization, it is known [SYZ] that

$$
\mathrm{S}_{\bullet}^{S Y Z}\left(C H_{0}(\mathrm{M})\right) \subset \mathrm{S}_{\bullet}^{V}\left(C H_{0}(\mathrm{M})\right) .
$$

We record the following easy lemma, providing a connection with the filtration (33).
Lemma 3. We have $\mathrm{S}_{i}^{S Y Z}\left(C H_{0}(\mathrm{M})\right) \subset \mathrm{S}_{i}\left(C H_{0}(\mathrm{M})\right)$, where M parametrizes stable sheaves with an arbitrary primitive Mukai vector $v$.

Proof. The fundamental Beauville-Voisin identity

$$
\bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdot \bar{\Delta}_{03}=0 \in C H_{2}\left(X^{4}\right)
$$

gives, for any point $x \in X$ :

$$
0=p_{23_{\star}}\left(\bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdot \bar{\Delta}_{03} \cdot p_{1}^{\star}[x]\right)=\left([x]-c_{X}\right)^{\boxtimes 2} \in C H_{0}\left(X^{2}\right) .
$$

For any collection of points $x_{1}, \ldots, x_{i} \in X$ we therefore have

$$
\left(\left[x_{1}\right]+\ldots+\left[x_{i}\right]-i c_{X}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(X^{i+1}\right) .
$$

Recall now that $S_{i}^{S Y Z}$ is generated by point classes $[F]$ for $F \in \mathrm{M}$ satisfying

$$
c_{2}(F)-k c_{X}=\left[x_{1}\right]+\ldots+\left[x_{i}\right]-i c_{X} \in C H_{0}(X)
$$

for a collection of points $x_{1}, \ldots, x_{i} \in X$. For any such $F$ we thus have

$$
\left(c_{2}(F)-k c_{X}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(X^{i+1}\right) .
$$

By (34), this means $[F] \in \mathrm{S}_{i}$.

Remark 4. It is known (cf [SYZ], OG2], [V5]) that the filtration $S_{\bullet}^{S Y Z}$ terminates after $n$ steps, $\mathrm{S}_{n}^{S Y Z}=C H_{0}(\mathrm{M})$. By the lemma, so does the filtration S 。 on $C H_{0}(\mathrm{M})$, and we have

$$
\begin{equation*}
[F] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n+1}=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{n+1}\right), \text { for all } F \in \mathrm{M} \tag{37}
\end{equation*}
$$

The subtler inclusion $\mathrm{S}_{i}^{V}\left(C H_{0}(\mathrm{M})\right) \subset \mathrm{S}_{i}\left(C H_{0}(\mathrm{M})\right)$ connects to properties of the filtration for higher-dimensional cycles, as we note in the next subsection.

Remark 5. It is useful to single out the subgroup

$$
\mathrm{S}_{i}^{\text {small }}\left(C H_{0}(\mathrm{M})\right) \subset \mathrm{S}_{i}\left(C H_{0}(\mathrm{M})\right)
$$

generated by point classes $[F] \in \mathrm{S}_{i}\left(C H_{0}(\mathrm{M})\right)$, for $F \in \mathrm{M}$. Via (34), the equality $\mathrm{S}_{i}^{S Y Z}\left(C H_{0}(\mathrm{M})\right)=\mathrm{S}_{i}^{\text {small }}\left(C H_{0}(\mathrm{M})\right)$ is implied by the following conjectural equivalence noted in [SYZ]: for a degree-zero cycle $\xi \in C H_{0}(X)$,
$\xi=\left[x_{1}\right]+\cdots+\left[x_{i}\right]-i c_{X}$ for a collection $x_{1}, \ldots, x_{i} \in X \Longleftrightarrow \xi^{\boxtimes(i+1)}=0 \in C H_{0}\left(X^{i+1}\right)$.
The obvious direction in this equivalence was already used in the lemma to show $\mathrm{S}_{i}^{S Y Z}\left(C H_{0}(\mathrm{M})\right) \subset \mathrm{S}_{i}^{\text {small }}\left(C H_{0}(\mathrm{M})\right)$.
4.3. The filtration for higher-dimensional cycles. Understanding the filtration S. in dimension zero is interestingly tied with properties of S . for cycles of higher dimension. We propose here the following generalization of identity (37).

Conjecture 4. Let $V \subset \mathrm{M}$ be a constant-cycle subvariety. Then

$$
\begin{equation*}
[V] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n+1}=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{n+1}\right) \tag{38}
\end{equation*}
$$

Here $[V]$ is pulled back as usual from the first M factor.
The vanishing is conjectured to hold for a product of $n+1$ normalized diagonals regardless of the dimension of the constant-cycle subvariety $V$. Thus when $[V] \in$ $C H^{n+i}(\mathrm{M})$, the conjecture positions the class of $V$ in the $i$ th piece of its Chow group,

$$
[V] \in \mathrm{S}_{i}\left(C H^{n+i}(\mathrm{M})\right)
$$

This matches an expectation formulated in [V1] regarding the placement of constantcycle subvarieties in a hypothetical filtration on all of $C H_{\star}(\mathrm{M})$ which would split the Bloch-Beilinson filtration. It reinforces $\mathrm{S}_{\boldsymbol{*}}$ as a strong candidate for this hypothetical filtration. Let us now observe

Lemma 4. The vanishing (38) holds if and only if $\mathrm{S}_{\bullet}^{V}\left(\mathrm{CH}_{0}(\mathrm{M})\right) \subset \mathrm{S}_{\bullet}\left(C H_{0}(\mathrm{M})\right)$.
Proof. We assume first that $\mathrm{S}_{\bullet}^{V}\left(C H_{0}(\mathrm{M})\right) \subset \mathrm{S}_{\bullet}\left(\mathrm{CH}_{0}(\mathrm{M})\right)$ and will deduce (38). Let $V=V_{F}$ be a constant-cycle subvariety for $F \in \mathrm{M}$ of dimension $n-i$, so $[F] \in \mathrm{S}_{i}^{V}$. By assumption we have

$$
\begin{equation*}
\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(\mathrm{M}^{i+1}\right) \tag{39}
\end{equation*}
$$

since $[F] \in \mathrm{S}_{i}$. We set

$$
\bar{\Delta}^{F}=\Delta-\mathrm{M} \times[F] \in C H_{m}(\mathrm{M} \times \mathrm{M})
$$

thus

$$
\bar{\Delta}=\bar{\Delta}^{F}+\mathrm{M} \times\left([F]-c_{\mathrm{M}}\right)
$$

The spreading principle gives

$$
\begin{equation*}
\left[V_{F}\right] \cdot \bar{\Delta}_{01}^{F} \cdot \bar{\Delta}_{02}^{F} \cdots \bar{\Delta}_{0, n-i+1}^{F}=0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{n-i+1}\right) \tag{40}
\end{equation*}
$$

Expanding, the two identities (39) and (40) now imply that
$\left[V_{F}\right] \cdot \bar{\Delta}_{01} \cdots \bar{\Delta}_{0, n+1}=\left[V_{F}\right] \cdot\left(\bar{\Delta}_{01}^{F}+\left([F]-c_{\mathrm{M}}\right)^{(1)}\right) \cdots\left(\bar{\Delta}_{0, n+1}^{F}+\left([F]-c_{\mathrm{M}}\right)^{(n+1)}\right)=0$.
(Here $\eta^{(i)}$ denotes the pullback of $\eta \in C H_{\star}(\mathrm{M})$ from the $i$ th factor to the product $\mathrm{M}^{n+1}$.)

Conversely, let us assume identity (38) holds, and let $[F] \in \mathrm{S}_{i}^{V}$, for $F \in \mathrm{M}$. Let $V_{F}$ be a constant-cycle subvariety for $F$ of dimension $j \geq n-i$. Let $D$ be an ample divisor on M. We have

$$
\left[V_{F}\right] \cdot D^{j}=a[F] \in C H_{0}(\mathrm{M})
$$

for a positive number $a$. By assumption,

$$
\left[V_{F}\right] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n+1} \cdot D^{(1)} \cdot D^{(2)} \cdots D^{(j)}=0 \in C H_{0}\left(\mathrm{M} \times \mathrm{M}^{n+1}\right)
$$

Pushing this cycle forward to the last $n-j+1$ factors of the product $\mathrm{M}^{n+1}$ we obtain

$$
a \cdot\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(n-j+1)}=0 \in C H_{0}\left(\mathrm{M}^{n-j+1}\right)
$$

As $j \geq n-i$, we have $n-j+1 \leq i+1$, therefore

$$
\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(\mathrm{M}^{i+1}\right)
$$

and $[F] \in \mathrm{S}_{i}$.

Remark 6. Let us note that in turn, the inclusion $S_{\bullet}^{\text {small }} \subset S_{\bullet}^{V}$ is equivalent to the following statement: for any point $F \in \mathrm{M}$ and any constant-cycle subvariety $V_{F}$ of maximal dimension in the orbit $O_{F}$, we have

$$
\begin{equation*}
\left[V_{F}\right] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n} \neq 0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{n}\right) \tag{41}
\end{equation*}
$$

Proof. This can be seen immediately as in the proof of the lemma above. Assume first that the inequality (41) holds as specified, and let $[F] \in \mathrm{S}_{i}$. We thus have $\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(i+1)}=0 \in C H_{0}\left(\mathrm{M}^{i+1}\right)$. Let $V_{F}$ be a maximal constant-cycle subvariety for $F$. Writing $\bar{\Delta}_{0 i}=\bar{\Delta}_{0 i}^{F}+\left([F]-c_{\mathrm{M}}\right)^{(i)}$ and expanding the product, we get

$$
\begin{aligned}
{\left[V_{F}\right] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n} \neq 0 } & \Longrightarrow\left[V_{F}\right] \cdot \bar{\Delta}_{01}^{F} \cdot \bar{\Delta}_{02}^{F} \cdots \bar{\Delta}_{0, n-i}^{F} \neq 0 \in C H_{\star}\left(\mathrm{M} \times \mathrm{M}^{n-i}\right) \\
& \Longrightarrow \operatorname{dim} V_{F} \geq n-i \Longrightarrow[F] \in \mathrm{S}_{i}^{V}
\end{aligned}
$$

Conversely, assume $\mathrm{S}_{\bullet}^{\text {small }} \subset \mathrm{S}_{\bullet}^{V}$. Let $F \in \mathrm{M}$ satisfy $\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(i+1)}=0$ but $([F]-$ $\left.c_{\mathrm{M}}\right)^{\boxtimes i} \neq 0$. By assumption then, a maximal constant-cycle subvariety $V_{F}$ satisfies $\operatorname{dim} V_{F}=j \geq n-i$. For an ample divisor $D$ on M we therefore have

$$
\left[V_{F}\right] \cdot D^{j}=a[F] \in C H_{0}(\mathrm{M})
$$

for a positive constant $a$. We consider the product

$$
\left[V_{F}\right] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n} \cdot D^{(1)} \cdot D^{(2)} \cdots D^{(j)} \in C H_{0}\left(\mathrm{M} \times \mathrm{M}^{n}\right)
$$

and note that its projection to the last $n-j$ factors in the product $\mathrm{M}^{n}$ is

$$
a \cdot\left([F]-c_{\mathrm{M}}\right)^{\boxtimes(n-j)} \neq 0 .
$$

We have used $n-j \leq i$. We conclude $\left[V_{F}\right] \cdot \bar{\Delta}_{01} \cdot \bar{\Delta}_{02} \cdots \bar{\Delta}_{0, n} \neq 0$.
